

Rules and Regulations

- All food must be provided by the YMCA. (No other food is permitted.)
- The concession stand will only be open for groups of 50 or more. (But for groups less than 50, a sack lunch is available @\$3.00 a person. This includes a hot dog, chips & a drink.)
- Rental includes the use of the Aquatic Center, Basketball Courts, Locker Rooms and Showers, X-Box Kinect, Ping-Pong and air hockey tables
- All Participants must pay the entrance fee regardless of Y membership.
- Only Coast Guard approved lifejackets are acceptable. The Coast Guard symbol must be legible. Children with lifejackets are not allowed down Big Blue Slide and must be within arms-reach of adults at all times. **Water wings are not allowed. No Exceptions.**
- Guests must have a swim suit to enter the pool, steam room and hot tub. No gym shorts, colored t-shirts or articles of clothing in the pool. Rash guard shirts, water shirts, surfing shirts are allowed.
- Aquatic Center Rules are posted and will be enforced .
- Children under 7 must have a 1:4 ratio - One adult in water for every 4 children under 8. These adults must be willing to get into the water and watch the children.
- Must be taller than 42" to ride Big Blue Slide. **Catching of children is not allowed.**
- Interactive area is designed for children under 7. Larger children may be asked to leave area
- Must be 16 to use adult facilities (hot tub, steam room and dry sauna) without a parent.
